

Section I. Invitation for Bids

1. The Republic of Lebanon represented by **the Ministry of Agriculture (MoA)** (hereinafter referred to as the “Purchaser”) received a **Grant from the International Fund for Agricultural Development (IFAD)** toward the cost of the Climate Smart Agriculture: Enhancing Adaptive Capacity of the Rural Communities in Lebanon (AgriCAL) Project and it intends to apply part of the proceeds of this Grant to eligible payments under the contract: **Procurement and installation of Fences for the Ministry of Agriculture.**

2. The Ministry of Agriculture invites sealed bids from eligible bidders for the Procurement of Fences for the Ministry of Agriculture.

The maximum duration for the supply and the delivery and commissioning and installation of the Goods is ninety **(90) days** after the signature of the Contract.
